# 1. TE PŪTAKE PURPOSE

The purpose of the report is to provide elected members with the updated Terms of Reference (ToR) for the Rotorua Future Development Strategy Joint Committee ("the Joint Committee), following the endorsement of the ToR by the Joint Committee.

# 2. NGĀ TŪTOHUNGA RECOMMENDATIONS

- 1. That the report 'Rotorua Future Development Strategy Joint Committee Terms of Reference Approval' be received.

### 3. TE TĀHUHU BACKGROUND

At the Community & District Development Committee ("the Committee") meeting on 17 May 2023 the committee approved the establishment of the Rotorua Future Development Strategy Joint Committee that will:

- serve as a hearings panel, to hear submissions and undertake deliberations.
- recommend to Rotorua Lakes Council ("RLC") and Bay of Plenty Regional Council ("BOPRC"):
  - any changes to the draft FDS; and
  - approval of a final version of the FDS by both local authorities based on the recommendations
    of the Joint Committee.

The Joint Committee membership comprises an independent chair (Greg Hill), three elected members from RLC (Cr Sandra Kai Fong, Cr Gregg Brown, Cr Rawiri Waru) and three elected members from BOPRC (Cr Nees, Cr Thurston, Cr TeTaru White).

The Joint Committee have met twice, on 23 May and 19 June.

# 4. TE MATAPAKI ME NGĀ KŌWHIRINGA DISCUSSION AND OPTIONS

At the meeting of the Joint Committee on 13 May, members agreed that officers/staff from RLC and BOPRC would make and agree on amendments to the ToR. The agreed ToR (see Attachment 2) was endorsed by the Joint Committee hui on 19 June.

The final ToR now needs to be approved separately by RLC and BOPRC as member councils of the Joint Committee. The attached ToR are therefore provided to the Community & District Development Committee for endorsement and approval.

Rotorua Future Development Strategy (FDS) Joint Committee Terms of Reference (ToR)

The Rotorua Future Development Strategy ("FDS") will promote long-term strategic planning by setting out how to achieve a well-functioning urban environment and provide sufficient development capacity to meet expected demand. The requirements for a FDS are set out in detail in Part 3 of the National Policy Statement on Urban Development ("NPS-UD") 2020 under the Resource Management Act 1991 (RMA).

The NPS-UD subpart 4 states that every tier 1 and 2 local authority must prepare and make publicallypublicly available a FDS for the Tier 1 and 2 urban environment. Rotorua Lakes Council ("RLC") and Bay of Plenty Regional Council ("BOPRC") are tier 2 local authorities 'jointly responsible' for the FDS. The NPS-UD states UD states that 'if more than one tier 1 or tier 2 local authority has jurisdiction over a tier 1 or tier 2 urban environment, those local authorities are jointly responsible for preparing an FDS as required by this subpart'.

Section 3.15 of the NPS-UD sets out minimum consultation requirements for developing FDSs. It is important to note that the Rotorua FDS will follow the Special Consultative Procedure (s83) under the Local Government Act ("LGA"). As such there is no appeals to the Environment Court, rather appeals are limited to points of law to the High Court or judicial reviews.

It is expected that the Rotorua FDS will inform the content of any Regional Spatial Strategy ("RSS") that may be required pursuant to the proposed Spatial Planning Act ("SPA") if that legislation is passed later in 2023.

This Terms of Reference ("ToR") focuses is for on the Rotorua FDS Joint Committee ("the Joint Committee"), including its purpose, membership—and delegations. Any additional Memoranda of Understandings ("MoUs") that are completed will be in addition, and complementary to, this Agreement.

The Committee has been established to focus on meeting the requirements for the process of preparing an FDS for the Rotorua tier 2 urban environment pursuant to the NPS-UD. The Committee carries out its purpose in accordance with the delegations set out in the ToR.

# ATTACHMENT 2: Rotorua Future Development Strategy (FDS) Joint Committee Terms of Reference (ToR) – final

#### Rotorua Future Development Strategy (FDS) Joint Committee Terms of Reference (ToR)

The Rotorua Future Development Strategy ("FDS") will promote long-term strategic planning by setting out how to achieve a well-functioning urban environment and provide sufficient development capacity to meet expected demand. The requirements for a FDS are set out in detail in Part 3 of the National Policy Statement on Urban Development ("NPS-UD") 2020 under the Resource Management Act 1991 (RMA).

The NPS-UD subpart 4 states that every tier 1 and 2 local authority must prepare and make publicly available a FDS for the Tier 1 and 2 urban environment. Rotorua Lakes Council ("RLC") and Bay of Plenty Regional Council ("BOPRC") are tier 2 local authorities 'jointly responsible¹' for the FDS. The NPS-UD states that 'if more than one tier 1 or tier 2 local authority has jurisdiction over a tier 1 or tier 2 urban environment, those local authorities are jointly responsible for preparing an FDS as required by this subpart'.

Section 3.15 of the NPS-UD sets out minimum consultation requirements for developing FDSs. It is important to note that the Rotorua FDS will follow the Special Consultative Procedure (s83) under the Local Government Act ("LGA"). As such there is no appeals to the Environment Court, rather appeals are limited to points of law to the High Court or judicial reviews.

It is expected that the Rotorua FDS will inform the content of any Regional Spatial Strategy ("RSS") that may be required pursuant to the proposed Spatial Planning Act ("SPA") if that legislation is passed later in 2023.

This Terms of Reference ("ToR") is for the Rotorua FDS Joint Committee ("the Joint Committee"), including its purpose, membership and delegations.

The Joint Committee has been established to focus on meeting the requirements for the process of preparing an FDS for the Rotorua tier 2 urban environment pursuant to the NPS-UD. The Joint Committee carries out its purpose in accordance with the delegations set out in the ToR.

# HUNGA: TIAKI HAPORI - COMMUNITY SAFETY

To transform community safety in public spaces to reflect Rotorua as the safest place to live, work and play in NZ through innovative approaches to partnership with central and local government, iwi, NGOs and community groups. To ensure a co-ordinated and responsive Council approach to community safety that is integrated across the district's regulatory and compliance services.

## Safe City Guardians/Patrols/CCTV

#### Key Focus for May:

- Community Safety is a key priority of the Council. To inform the Draft Community Safety Strategy, development of environmental scans to understand the current state, areas for intervention and long term planning continue.
- Visibility, responsiveness and reassurance to our communities are central to decision-making regarding RLC patrols.

Community Safety Teams through their weekly reporting have observed that mental health and graffiti continue to remain a challenge in the CBD. Council teams are actively monitoring these issues.

#### **Emerging Issues:**

Noticeable increase in rough sleepers. Council's Safe City Guardians and Thriving Community team are connecting clients to support services.

#### Operational Activity:

- Preliminary work completed in partnership with Police to identify potential new sites for CCTV cameras.
- Trolley situation has improved with retailer support and information gathering on begging activity continues.

#### **Animal Control**


- Staff continue to address stock attacks in the Brunswick area. There have been four attacks to date. The random nature of the attacks has proven challenging. Investigations continue.
- Dog registration follow ups continue for collection of outstanding fees for the current financial year.

#### **Parking**

- Parking Policy Encouraging levels of compliance, is an important aim of Council's Parking policy.
- Cash payment 8.9% of total revenue and 16% of transactions.

Number of Parking Transactions per Infringement (Compliance)

- Card payments 33% of total revenue and 37.3% of transactions.
- App payments 58.1% of total revenue and 46.7% of transactions.
- Parking infringements increased this month with 2,330 issued (93 infringements a day).
- The overall number of people correctly paying for parking however, also increased from the previous month. Most infringements were for overstaying the time limit, followed by non-payment.
- The graph below tracks the relationship between the total number of infringements issued and the number of people who have successfully paid for parking (compliance).



### Consent investigation

Council has been made aware that a non-chartered professional engineer has allegedly been completing and signing documents using the identity of various chartered professional engineers without their permission. Council is supporting the investigation currently underway.

### Future Development Strategy (FDS)

Following pre-engagement the draft FDS was completed and presented to Council on 17 May and was approved for public consultation from 1 June to 14 July.

Independent commissioner Greg Hill was appointed as chair of the Rotorua FDS Joint Committee consisting of RLC and BOP Regional Council members. The Committee met 23 May.

The FDS was presented at the Tūhourangi protocol meeting. Separate updates on the draft FDS were also provided to MHUD and Kāinga Ora officials.

The joint committee have reviewed the terms of reference (TOR) for the process and have sought amendments by Council of the TOR. This was submitted to Council for approval.

# MBIE Determination

Council has received the MBIE determination on the Ashleigh Court motel's change of use under the Building Act. The determination supports Council's assessment that a change of use had occurred between *sleeping accommodation* and *sleeping residential* during the period the motel was used for emergency housing. Councillors will be aware that a determination relates to the specific property only, and at a specific point in time. However, it does provide the key questions/information and evaluation on which MBIE made their determination. This will provide a level of confidence to Council's regulatory enforcement approach.

### Hazard Mapping supporting future Natural Hazard Plan Change

Initially the need for a hazards plan change was to amend gaps in flood hazard management, building on the analysis and issues identified by the Ngongotaha Flood Hazard Review Panel.

Some of the gaps in the District Plan are now proposed to be addressed through PC9, narrowing the scope of this potential plan change. However, a plan change is still considered necessary to address issues not addressed in PC9, such as the management of overland flow paths.

There is also potential for the hazards plan change to further strengthen geothermal hazard management through the District Plan, building on changes being considered specifically for Rotorua City in PC9.

Alongside this, work has begun to fill gaps in flood hazard mapping. Flood hazard modelling for Ngongotahā to Awahou is currently underway. Council plans to release flood hazard mapping for an eastern catchment later this year and is considering how to improve hazard mapping in the west of the city.

#### HOUSING ENABLEMENT

# Housing for Everyone – Plan Change 9

- Still on track for hearings scheduled for August 2023.
- On 30 June 2023 Council officers' reports addressing the submissions received and technical evidence will be published online in advance of the PC9 hearing in August 2023.

#### **Development Support**

• The team is currently supporting **29** residential developments in pre-lodgement phase (prior to lodging Resource Consent).

#### Partnership Developments

- Negotiations with the preferred developer for the Council-owned surplus land at 283 Clayton Road are continuing.
- Expressions of Interest process, closing 14 July, currently underway to identify developer/purchaser to develop the Council-owned surplus land at 61 Kawaha Point Road and the adjacent unformed road.
- Awaiting approval from Pukeroa Oruawhata Trust to start the change in purpose process for part of Rotorua Cemetery Reserve to enable the development of community housing.

### WHAKAWHANAKETANGA ŌHANGA – ECONOMIC DEVELOPMENT

### Council-Controlled Organisation (CCOs)

- Statements of Intent (SOIs)
  - O Council commented on the draft statements of intent for RotoruaNZ Limited and Rotorua Regional Airport Limited, including the performance measurements.
  - Currently working with both CCOs to finalise SOIs. The respective CCO boards are required to respond by the end of June with their final SOIs.
- Board appointments
  - Advertisements were placed for new directors and a chairperson for Rotorua Regional Airport Limited and for new directors for RotoruaNZ Limited on 12 May 2023 with applications closing 12 June 2023.
  - 41 applications were received for RotoruaNZ and 85 for Rotorua Regional Airport Limited and subject to approval from the Community and District Development Committee, appointments are expected to be made by July.

#### Forest Futures Action Plan (FFAP)

The Forest Futures Action Plan will be presented to the Committee in the near future. The importance of forestry to the region was recognised with the drafting of Rotorua Lakes Council's Economic Development Framework (2020). Forestry was highlighted as one of three priority areas for development of a more detailed Action Plan and RLC and RotoruaNZ have jointly taken the lead and responsibility for this.

#### Airport Business Park Support

- Detailed comments were provided to the Airport and Veros Consulting on the latest draft pre-feasibility report (dated May 2023) for the airport business park.
- Key issues impacting feasibility of the business park development have been identified as: stormwater, contamination and geo-technical conditions with stormwater the most significant constraint.
- Detailed technical studies are required on the above elements to ascertain the extent of land suitable for development and viability thereof. Briefs for these studies are being prepared and reviewed.

#### INNER CITY REVITALISATION & FENTON STREET CORRIDOR

#### Research

- Revitalisation of the inner city has been identified as a key priority for Council. To inform the Inner City Master and Precinct Plans, RLC is conducting detailed research to understand the current status (base line), areas for intervention and long-term planning implications.
- Inner city profile:
  - o Main report has been completed with the exception of consumer data.
- Retail Study and improvement plan:
  - RFP issued to four companies, closing 25 May 2023.
  - Just one submission received, from retail specialist consultant firm which has extensive experience with individual retailers but not at a city level. Submission evaluated and discussions held with the firm but they are unfortunately not able to fulfil the brief as required. Other options are being investigated including splitting the work and discussions are being held with leading property research companies.

### Wayfinding/Cultural Foundations

- Wayfinding:
  - Oversight Committee established including Te Arawa representation.
  - Preferred bidder was identified but despite extended negotiations could not deliver the scope of works within the budget for this project. Discussions being held with a second tenderer and an appointment was anticipated to be made by the end of June.
- Cultural foundations:
  - Agreement reached with all parties to incorporate the cultural foundations work into the Wayfinding project.
  - Meeting held with Te Tatau o Te Arawa to better understand their expectations.
  - o Required narratives and capacity to deliver these being identified.
