## 4 NGĀ TAKE WHAWHATI TATA KĀORE I TE RĀRANGI TAKE URGENT ITEMS NOT ON THE AGENDA

### **Elected members emails**

Cr Macpherson expressed concerns there were some blockages from his private email and requested the blockages be removed to allow full access with elected members and council officials.

The Chair ruled this was not an urgent item and was a technical matter.

Cr Bentley was concerned that senior management were censoring materials sent to elected members.

Cr Donaldson raised a point of order (language) and said censorship was a strong claim to direct to staff as they were following requests from other elected members. Cr Donaldson asked Cr Bentley to withdraw his comment.

The Chair upheld Cr Donaldson's request advising it was a disrespectful and asked Cr Bentley to withdraw the comment and apologise.

Cr Bentley asked for assurances that staff would no longer review elected members emails.

The Chair asked Cr Bentley again to withdraw and apologise for the use of the word censorship. Cr Bentley said he could not offer another word as a substitute. The Chair said if he was not prepared to withdraw and apologise, he would have to leave the meeting.

Cr Raukawa-Tait provided the word screening as a substitute, which Cr Bentley agreed to. However, after consideration the Chair was not satisfied with screening and asked the Chief Executive Geoff Williams to speak to the matter.

Mr Williams clarified, staff do not screen, read or intervene with emails unless elected members raise concerns. Mr Williams said the matter occurred when elected members asked staff to act on their behalf when a large volume of identical emails, from the same source, were sent to their mailboxes and they were not able to access their legitimate emails.

The Chair agreed this was the situation and said she would not accept the word screening.

Cr Bentley agreed to withdraw and apologise.
