# 6.1 Permanent alcohol ban for Rotorua Community Youth Centre Reserve, Marist St Michaels Sports Park Reserve, Shambles Theatre Reserve and lots 2, 3, 4, 5 DPS 65170

# 1. TE PŪTAKE PURPOSE

The purpose of the report is to recommend Council make a resolution for a Temporary Alcohol Ban (Ban) for Rotorua Community Youth Centre Reserve, Marist St Michaels Sports Park Reserve, Shambles Theatre Reserve and Lots 2, 3, 4, 5 DPS 65170 that sit adjacent to these Reserves, be made permanent.

# 2. TE TUHINGA WHAKARĀPOPOTOTANGA EXECUTIVE SUMMARY

Both NZ Police and Council have repeatedly received reports of crime and disorder related to the Rotorua Community Youth Centre Reserve, Marist St Michaels Sports Park Reserve, Shambles Theatre Reserve and Lots 2, 3, 4, 5 DPS 65170 that sit adjacent to these Reserves. This crime and disorder has occurred over a number of years and the baseline for measuring offending has changed with increased social issues and homelessness occurring on and around Fenton Street.

Alcohol consumption in public areas creates problems which are occurring day and night, throughout the week. Urinating, defecating, littering (broken bottles, aluminium cans, used hypodermic needles, general rubbish), disorderly behaviour (fighting, intimidation), damage to buildings and sleeping overnight are some of the behaviours occurring.

While tools have been utilised to deal with this crime and disorder, these have not been effective or timely for reducing the behaviours. However, in February 2021 Council adopted a proposal for temporary alcohol ban areas, which put in place Alcohol Free Zones in public places that had been recorded in Council and police reports to have high crime rates linked to alcohol. The Bylaw enforced the Temporary Alcohol Ban areas from 27 February 2021 – 27 February 2022. These were reinstated from 27 February 2022, and are due to lapse on 27 February 2023. This time provided a 'trial' period in which Council could quantify the success of implementing such measures. After a successful period, Council now wishes to make these temporary zones permanent under the Rotorua District Alcohol Ban Bylaw 2018.

### 3. NGĀ TŪTOHUNGA RECOMMENDATIONS

- 1. That the report 'Permanent Alcohol Ban for Rotorua Community Youth Centre Reserve, Marist St Michaels Sports Park Reserve, Shambles Theatre Reserve and Lots 2,3,4, 5 DPS 65170' be received.
- 2. That Council resolves to introduce a permanent alcohol ban area for the Shambles Theatre Reserve, 24 hours a day and seven days a week.
- 3. That Council resolves to introduce a permanent alcohol ban area for the Rotorua Community Youth Centre Reserve, 24 hours a day and seven days a week.
- 4. That Council resolves to introduce a permanent alcohol ban area for the Marist St Michael's Sports Park Reserve, 24 hours a day and seven days a week.
- 5 That Council resolves to introduce a permanent alcohol ban area for Lots 2 DPS 65170, Lot 3 DPS 65170, Lot 4 DPS 65170 and Lot 5 DPS 65170, 24 hours a day and seven days a week.

#### 4. TE TĀHUHU BACKGROUND

Alcohol-related crime or disorder has been occurring across three adjacent Council Reserves and on the Lots owned by Council for a number of years. Tenants of each of the Reserves, Council officers and Police noticed a significant increase in the level of the crime and disorder over the 2020 – 2021 year (not including the COVID lockdown period) leading up to the decision to enforce temporary alcohol bans in the areas in question.

#### **Tenants**

#### **Rotorua Community Youth Centre Reserve**

Rotorua Community Youth Centre first contacted Council re alcohol related behaviours occurring on the Reserve surrounding the Centre in March 2020. Behaviours included drinking on site, defecation, urination, intimidation and antisocial behaviour, fighting, and rubbish being strewn including broken bottles and torn aluminium cans. The regularity of this behaviour, and having adults under the influence of alcohol, in the vicinity of young people is a major health and safety risk.

#### Marist St Michael's Sports Park Reserve

Marist St Michael's Rugby and Sports Club repeatedly raised concerns regarding adults "hanging out" and drinking in their Reserve, defecation, damage to the buildings, theft, intimidating and antisocial behaviour and significant amounts of rubbish (cans, bottles and hypodermic needles). Children (as young as four years old) and young people are an integral part of the Marist St Michael's Club and are exposed to these health and safety risks.

#### **Shambles Theatre Reserve**

Rotorua Shambles Theatre lodged ongoing reports of adults drinking and sleeping and lighting fires on the decks of the buildings and in the Reserve, intimidating and antisocial behaviour, defecation and rubbish. There were safety concerns for Theatre staff and children attending drama classes during the day.

#### **Council Owned Land**

Council owns Lots 2 DPS 65170, Lot 3 DPS 65170, Lot 4 DPS 65170 and Lot 5 DPS 65170. The Council Property Team dealt with issues of defecation, urination and vandalism. These areas are recommended to avoid the inevitable migration from the Reserves as the Bans occur and to protect the tenants. Currently Te Whānau Tokotokorangi Trust are the tenants of the building at 14 Te Ngae Road and provide services for people with intellectual and physical disabilities, including to youth and young adults who are vulnerable.

#### **Examples of complaints**

Council officers from Regulatory; Sport, Recreation & Environment, Strategy; Customer Solutions; and Property have high awareness of the alcohol-related crime or disorder on all three of the Reserves and Council Lots. Examples of complaints related to these Reserves include:

**18 December 2020. Shambles Theatre Reserve** – "Customer has called to ask if guardians can assist with an ongoing issue with homeless drinking around the Shambles Theatre. Customers noticed that around 3pm when the kids' classes are starting they have been getting a lot of vagrants showing up and drinking around the building passing out getting high and being a disturbance. He asked if we can please help in anyway".

16 December 2020. Rotorua Community Youth Centre Reserve. "Yet again adult drinkers have been asked to move on from drinking on the Council Reserve at 6 Te Ngae Road today at 10am. A group of two adults consuming alcohol who could barely stand parked themselves under a tree next to our driveway (a great look for youth and parents alike). This matter was referred to the police ...... this is becoming a bigger problem and is no longer safe for youth. We are seeking a solution as we are at our wits end. Due to the daily risk of regular broken bottles, torn aluminium cans and other rubbish that is constantly left behind by vagrants drinking onsite, not to mention the danger of having drunk adults hanging around a youth space, this is a major health and safety risk to young people and a permanent solution is sought".

**27 January 2021. Marist St Michaels Reserve**. "Request for the bin to be reinstated where the old playground used to be because the homeless hang out and drink in the Reserve, particularly up along their back clubrooms fence under the shade of the tree and then throw their rubbish over into the clubrooms yard. The volume has gotten worse...they have found hypodermic needles as well. On average they easily fill a wheelie bin and there have been times up to a few times a week, usually consisting of cans and bottles".

#### **Rotorua Police**

Police data on 'alcohol related' incidents and offending, before the temporary ban was in place, confirmed that they were called to the Reserves in question at least four to five times per week in response to disorder, antisocial behaviour and violence offences, all usually alcohol related.

The Police note that the three Reserves are used by homeless persons as a gathering point and often dwellings are set up in these areas. Signs of alcohol consumption, defecation and rubbish are always present.

The Police have highlighted the inconsistency between the alcohol related crime and disorder and the activities of the Reserve users involving children and young people.

Since the temporary ban has been in place The Police have had the powers to be able to prosecute those offences that have been alcohol related and move people on who are misbehaving around vulnerable people such as children.

The Police also noted that the baseline for the crime reported in these areas has been exacerbated over recent months due to compounding factors including increases in homelessness, a disproportionate housing deficit in Rotorua and the effects of the Covid19 pandemic.

#### Tools Already Utilised to Deal with the Alcohol-Related Crime and Disorder

The Table below identifies the tools previously utilised by Council and Police to manage the alcohol-related crime and disorder occurring in the three Reserves and Council Lots. None of these tools provide a mechanism for dealing with persistent alcohol-related crime and disorder over multiple reserves in an effective and timely manner.

# 5. TE MATAPAKI ME NGĀ KŌWHIRINGA DISCUSSION AND OPTIONS

There is a large amount of support for the proposed change to make the current Temporary Ban areas around Te Ngae Road permanent. This proposal aims to reduce the harmful impact of alcohol. Alcohol related harm includes the burden of harm on the community, as well as the harm caused to the health of individuals. The introduction of a permanent Liquor Ban Area, will keep our youth and young people safe, aligning with our community safety targets and give Police effectively double the scope to deal with alcohol related incidents before they escalate. This proposal also provides Police with an increased range of options for dealing with alcohol related offending, which will result in a reduction in the alcohol related harm.

#### **Overall comments:**

#### In support of proposal:

- It is believed that permanent bans will lead to a reduction in alcohol related crime and antisocial behaviour in the area.
- Since the instatement of the temporary ban there has been a noted reduction in the amount of intoxicated, violent, loud and drug-influenced people loitering in these areas, as well a reduction in litter, especially broken glass, and cigarette butts being left.
- This is a logical step towards providing a safe space for our youth and people in the community.
- This is the only tool we have for responding to alcohol related incidents occurring in the areas in question.
- The area is a hot spot for homeless and emergency housing clients for consuming alcohol, which contradicts its intended usage for whanau and rangatahi playing sports etc.
- We should be providing safe community spaces where rangatahi can feel safe and comfortable
  using the facilities not having to worry about being harassed or feeling intimidated.
- While there is the option of enforcement, the key aim is reducing harm and making Rotorua a safer area for all in the community.

#### Other:

- Agree with the non-alcohol areas around the Rotorua Youth Centre and other proposed zones, but not with the Marist St Michaels Rugby and Sports Club. There is an enjoyable culture at the club and whanau should be able to go and watch sport and enjoy a beverage while doing so in moderation.
- Need to give better consideration to the people who are drinking in these areas and why. Just banning them from public spaces is not a solution to the complex challenges that these people are facing, such as alcoholism, homelessness and abuse etc.

#### Areas to be covered by a Permanent Alcohol Ban

The location and scope of the each of the Reserves and the Council Lots is outlined in Attachment 1. The Rotorua Community Centre Reserve is shaded in orange, the Shambles Theatre Reserve is shaded in blue, the Marist St Michaels Sports Park Reserve is shaded in yellow and the Council Lots are shaded in green.

#### **Need and Support for Permanent Alcohol Bans**

Previous tools have not been effective for dealing with the high and increasing level of alcohol related crime or disorder in the areas of concern. However, the trial period with a temporary ban in place has empowered The Police with the ability to prosecute offences on the basis of alcohol consumption and to better keep our communities safe.

The Rotorua Community Centre, Marist St Michael's Rugby and Sports Club, and Rotorua Shambles Theatre, Te Whānau Tokotokorangi Trust, Council Officers and Rotorua Police have expressed strong support for the temporary ban to be made permanent. All of these groups advocate the Ban has had some success in curbing the previous behaviours and given the Police the ability to prevent other offences from occurring. The areas proposed are: Shambles Theatre Reserve; Rotorua Community Centre Reserve; Marist St Michael's Sports Park Reserve; and Lots 2, 3, 4, 5 DPS 65170.

Council Officers and Rotorua Police agree making the Temporary Alcohol Ban Areas permanent is appropriate and proportionate given the alcohol-related crime and disorder that has occurred and continues on the Reserves. A Ban is considered to be a justified and reasonable limitation on people's rights and freedoms.

#### **Making the Temporary Alcohol Bans Permanent**

In considering a resolution to create Permanent Alcohol Ban Areas, Council must comply with the general decision making requirements of the Local Government Act, as well as meeting the evidential requirements of the Local Government Act and Council's Bylaws. The information supplied within this report meets these requirements.

Before a Ban comes into effect the Council must give public notice of the Ban not less than 14 days in advance.

After declaring a Permanent Alcohol Ban Area, Council must erect permanent signage in accordance with section 7 of the Rotorua District Alcohol Ban Bylaw 2018, no less than seven days prior to the Ban taking effect. The size, location and content of the signage is left to Council's discretion, however, the sign should specify the time period the Ban will apply. It is recommended this should be 24 hours a day, seven days a week.

### 6. TE TINO AROMATAWAI ASSESSMENT OF SIGNIFICANCE

The decisions in this report concern a bylaw, and are considered significant in accordance with the Local Government Act 2002, and the Council's Policy on Significance. As a significant decision, Council must apply greater diligence to the decision—making requirements of the Local Government Act 2002. This includes, but is not limited to, the degree to which different options are identified and assessed and the extent to which community views are considered.

# 7. HE WHAIWHAKAARO CONSIDERATIONS

#### 7.1 Mahere Pūtea

#### Financial/budget considerations

Costs will be incurred erecting and maintaining signage on each of the three Reserves and on the Council Lots, notifying users of the Ban, 14 days before the Ban takes effect.

# 7.2 Kaupapa Here me ngā Hiraunga Whakariterite Policy and planning implications

The recommendations within this report align with Vison 2030 (Outstanding Places to Play, Vibrant City Heart), Homes and Thriving Community Strategic Framework (Thriving Communities, Community Safety Planning) and the intent of the Rotorua District Alcohol Ban Bylaw 2018 to reduce alcohol-related harm, damage, disorder and crime and to improve community safety by putting alcohol restrictions in some public places.

#### 7.3 Tūraru Risks

The alcohol-related crime and disorder occurring on the three Reserves and on the Council Lots, prior to the instatement of the temporary ban, had been increasing and reached a point where there was

risk to the safety and health of users. Of particular concern is the risk to those children (as young as four years old) and young people who use the tenants' facilities. Tenants and users are dealing with the adverse effects of this crime and disorder on a daily/weekly basis. Both Council officers and Rotorua Police are aware of the health and safety risks.

# 3. **TE TĀHUHU BACKGROUND**

- 1. Housing for Everyone Plan Change 9 is a change to the District Plan to encourage greater development and housing, and it forms part of a series of actions the Government has developed to address housing in New Zealand. The plan change will enable greater housing choice in Rotorua by amending the current rules. Plan Change supports intensification by enabling medium density living across most of the urban area, and high density living close to and in the city centre and commercial centres.
- 2. Homes for Everyone Plan Change 9 was released for community consultation on 20<sup>th</sup> August 2022. Feedback/submissions closed on 14<sup>th</sup> September 2022.
- 3. A summary of submissions will be available on 12 November 2022 and allow further submissions for the statutory two-week period. A presentation will be provided detailing the key issues in submissions and how people or groups can participate in further submission process.
