1. TE PŪTAKE PURPOSE

The purpose of this report is to seek support from Council to proceed with the development of an accord to bring together the collective insights and resources of the Crown, Rotorua Lake Council and Te Arawa Iwi to address the current housing shortfall, and to meet future housing needs in the Rotorua District.

3. TE TĀHUHU BACKGROUND

- Rotorua has a housing shortage, coupled with this is a significant number of households are in emergency housing (motel accommodation) and this is unacceptable to Council and the residents/community of Rotorua.
- There is a shared view that urgent change is needed before the end of 2022 to begin to mitigate unintended adverse social and economic impacts of this housing emergency on the Rotorua community.
- 3. The Crown, Iwi and Council have committed to jointly working together on a plan (accord) to address these issues.

4. An update on the development of this accord will be provided in the meeting, and Council will have the ability to test and revise the objectives and actions being proposed in a draft accord (under preparation at the time of writing this report).
