Kaianga Ora Houses to be built in Devon St/ Wylie Street and the surrounding neighbourhood

No doubt you will be aware of the purchase by Kainga Ora of land in Devon Street (54) and that they also tried to purchase but were unsuccessful, another section on the corner of Devon and Batten Streets and also a derelict house and land in Wylie Street. We have been advised that the plan is to build four two story houses and two single story houses on the purchased land in Devon Street. As close neighbours we are very concerned because of the following outlined below.

Tenants don't go through normal checks

Kainga Ora build the houses but MSD provide the tenants. This means that tenants do NOT have the expected CHECK done on them such as a police check, credit check, references from previous landlords, etc.

Expect anti social behaviour, drug use and issues

Tenants who do not respect others by undesirable, unacceptable and anti social /aggressive behaviours do NOT expect to be EVICTED because of the residential tenancy act. We will be the one to suffer in the end.

Our peaceful lives may be affected

The outcome of this would be that the people in the neighbourhood, made up of hard working, rate paying home owners (in most respects) and senior citizens some of whom live in a retirement village, would be badly impacted. The change to our normally safe and peaceful environment would be huge.

House values will drop

One aspect that many home owners in the area may not realise is that by having this development on our doorstep will DEVALUE their property. Kainga Ora denies this but in reality it will have an instant effect.

You (and your friends even if they do not live in this area) are therefore invited to a meeting to be held on <u>Monday 31 October at the CT Club</u>. Moncur Drive from <u>3.30pm to</u> <u>6:00pm</u>.(Please come along even if you cannot make the start of the meeting!) Local and national staff of Kainga Ora will be in attendance. This may be a last chance to stop Kainga Ora ruining our peaceful area and changing it into long term emergency housing area!
