BUSINESS CASE - MAYOR'S ATTENDANCE AT SISTER CITY 100 YEAR ANNIVERSARY COMMEMORATIONS

1. TE PŪTAKE

PURPOSE

In May 2023 Mayor Tapsell received an invitation from the Mayor of Beppu City to attend the Beppu City 100 year anniversary celebrations. The celebrations are scheduled for the 6 $^{\rm th}$ and 7 $^{\rm th}$ April 2024.

The purpose of this report is to advise Councillors of the upcoming 100 year anniversary celebrations of Beppu City Council - a Sister City of Rotorua since 1987, and to seek Council approval for travel and accommodation costs for the Mayor, supported by an interpreter, to attend the commemorations in Beppu City.

This report also includes a recommendation that to optimise this opportunity, the Mayor visit Rotorua's Sister City in Wuzhong, China – a Sister City of Rotorua since 2000.

2. HE TÜTOHUNGA RECOMMENDATION

- That the report 'Business Case Mayor's Attendance at Sister City 100 Year Anniversary Celebration' be received.
- That Council approve the cost of flights and accommodation for Mayor Tapsell, and an interpreter, to attend the 100 year anniversary celebrations of Beppu City Council, Japan, 6th and 7 th April 2024.
- 3. That Council approves the additional cost of flights and accommodation for Mayor Tapsell to visit Rotorua's Sister City in Wuzhong, China.
- 4. That Council note that income generated by delegates visiting Rotorua Lakes Council will exceed the cost of this proposed travel.

3. TE TĀHUHU BACKGROUND

Rotorua Lakes Council has four sister cities: Beppu (Japan), Klamath Falls (USA), Lake Macquarrie (Australia) and Wuzhong District of Suzhou City (China). These relationships are long standing and were undertaken via the international Sister Cities programme between 1962 and 2000. The international programme seeks to foster communications across borders to promote the mutual exchange of ideas, people and materials in cultural, educational, youth, sports, municipal, professional and technical projects.

Over recent decades Council has seen a decline in active contact with some of its sister cities, however the relationships between Rotorua and our sister cities in Beppu and Wuzhong are enduring.

Beppu City, Japan

Rotorua has had a Sister City relationship with Beppu City since 1987. When established, the relationship was seen as being mutually beneficial due to both cities being sited in geothermal locations, both being recognised as Spa Cities and both having strong interests in tourism. Former Mayor Graham Hall notes that over the years "successive Mayors of both cities, with strong support from their communities, have progressed a mutual exchange of ideas and people with culture, education, youth, sport, and municipal and business projects."

In recent years, prior to 2019 and the Covid pandemic, Rotorua Lakes Council and others in our community regularly hosted delegations, rugby tours, school (Western Heights, John Paul College and Rotorua Boys High School) and University visits from Beppu. There were also rugby tours, community delegations and school visits to Beppu over this time. Mayor Chadwick visited Beppu on two occasions in 2014 and 2016 to foster good relations and support spa/tourism opportunities.

The relationship was particularly active between 2016 and 2019 when Rotorua Lakes Council provided advice and support to Beppu City Council on preparing Beppu as a host city for the 2019 Rugby World Cup and supported Beppu's efforts to host the All Blacks.

A current initiative being explored by the Beppu Chamber of Industry and Commerce is a proposed mutual exchange program through rugby for high school students, supported fully by Beppu City's business community.

Wuhzhong District, China

Rotorua established its Sister City relationship with Wuzhong District, Suzhou City, in 2000. At that time, the relationship was seen as beneficial due to Wuzhong's strong linkage and close proximity to Shanghai; and its fit with Rotorua's target markets - education and tourism. While this relationship has not seen the same level of activity as the Beppu relationship, there is regular contact. The last visit of a Mayor and Councillor to Wuzhong was in 2017.

4. TE MATAPAKI ME NGĀ KŌWHIRINGA DISCUSSION AND OPTIONS

In May 2023 Mayor Tapsell received an invitation from the Mayor of Beppu City, Mr Yasuhiro Nagano, to attend the Beppu City 100-year anniversary celebrations. The celebrations are scheduled for the 6 $^{\rm th}$ and 7 $^{\rm th}$ April 2024 (See attachment 1).

As part of the invitation, Beppu City Council has offered to cover the costs of lodging, meals, transportation upon arrival in Beppu City, and attendance at events for the mayor and entourage, totalling three persons for two nights.

Council's Sister City Relationship Policy and Mayoral and Elected Representatives International Travel Policy requires that requests for travel that relate to Sister City relationships be supported by a business case that outlines the benefits of the travel against the following criterion:

- The travel/activity must support council's vision, business objectives and aspirations for the future as encapsulated in the Long Term Plan, or
- The travel must support council's current priorities and/or flagship projects.

This proposed travel to Council's Sister cities in Japan and China has two key objectives, based on renewing our city's international relationships, that have been seriously affected by the two-year closure of Rotorua's borders during Covid 19.

1. The first objective, **to renew the close community ties between Rotorua and its two most significant sister cities**, is an acknowledgement to the citizens of Beppu and
Wuzhong and the many individuals and groups in our own community who have their own
relationships with Beppu City and Wuzhong, that this significant relationship has resumed.

As well as attending the commemorative events in Beppu, the Mayor's Office is preparing an itinerary for Mayor Tapsell that will include meetings with Mayor Nagano and with members of the Oita Prefecture New Zealand Friendship Association – re-establishing the civic ties between our cities. It will also include a visit to Beppu Shosei High School – a sister city school that has a strong and active relationship with Western Heights High School. 8,000 students from Beppu have visited Rotorua since the exchange programme began in 2001. Exchanges have recently been re-established for social, cultural and economic benefit.

The Mayor's Office is also in contact with Wuzhong City Council to identify similar opportunities to meet with Council leaders and identify exchange opportunities.

The second objective, to renew and seek new commercial relationships between
 Rotorua and its two most significant sister cities is an acknowledgement that business to business relationships between our communities has also suffered due to the border closures during Covid.

The Mayor's Office is also working through their counterparts at Beppu City Council to seek meetings with the representatives from the Beppu Chamber of Industry and Commerce.

A current initiative being explored by the Beppu Chamber of Industry and Commerce is a proposed mutual exchange program through rugby for high school students, supported fully by Beppu City's business community.

An opportunity for Mayor Tapsell to view an Onsen Spa and share information on Rotorua's spa industry, including recent developments, is also being investigated. The strong cultural elements of these geothermal offerings also make this a unique opportunity for sharing insights and learnings for success.

The Mayor's Office is also in contact with Wuzhong City Council to identify similar opportunities to meet with Council leaders.

7. HE WHAIWHAKAARO CONSIDERATIONS

7.1 Mahere Putea

Financial/Budget Considerations

The estimated costs for flights and accommodation related to Japan and China are included in the table below, noting that:

- Beppu city will cover the costs of lodging, meals, transportation upon arrival in Beppu City, and attendance at events for the mayoral party, totalling three persons for two nights.
- Income from income generating delegations hosted since August 2023 by Mayor Tapsell will exceed the cost to Council of the proposed travel. The current income generated is \$3,800.00. This income is expected to increase before the Mayor travels in 2024. In the past this has averaged \$23,500.00 per year. Therefore the cost of this travel will eventually be balanced out.

There have not been Mayoral visits to Beppu or Wuzhong since 2016 and 2017 respectively. If civic and commercial links with our sister cities are not maintained they may be difficult to reestablish.

It is a great pleasure to be sending you this letter for the first time from your sister city, Beppu City, Oita Pref., Japan.

I am NAGANO Yasuhiro, Mayor of Beppu City, recently elected to my third term as mayor of Beppu City in the April 23rd mayoral election.

I assume you have been very busy doing a lot of duties as Mayor of Rotorua since taking office as mayor last October. In the meantime, we have heard that you will give birth to a baby girl next month. We would like to offer our heartfelt congratulations.

We concluded a sister city agreement with your city in July 1987 and celebrated the 35th anniversary of our affiliation last July. We have had a sister school relationship, mutual school exchanges, and sports exchanges such as rugby, which have been invaluable for our children. In addition, both cities share a common resource in the form of hot springs, and we are proud that we can continue to cooperate with each other in many ways in the future.

Policy Purpose:

To guide decision making in relation to council's sister city relationships.

Policy:

Rotorua Lakes Council (Council) has four sister cities: Beppu (Japan), Klamath Falls (USA), Lake Macquarrie (Australia) and Wuzhong District of Suzhou City, China. These relationships are long standing and were undertaken via the international Sister Cities programme between 1962 and 2000. The international programme seeks to foster communications across borders to promote the mutual exchange of ideas, people and materials in cultural, educational, youth, sports, municipal, professional and technical projects.

Over recent years Council has seen a decline in active contact with the majority of its sister cities. As part of the 2016 review all relationships are considered null and void unless contact is initiated and sustained by current sister cities and when that contact is considered beneficial to Council.

Proposed travel that relates to a sister city relationship needs to be supported by a business case that outlines the benefits of the travel against the following criterion:

The travel/activity must support council's vision, business objectives and aspirations for the future as encapsulated in the Long-term Plan, or

The travel/activity must support council's current priorities and/or flagship projects.

The business case to be approved by a recommendation from the CEO to council.

Generally travel costs of accompanying persons will not be paid for.

At the conclusion of the travel the elected representative/staff member is required to provide a written report to council.

This policy does not include travel by elected representatives that has been undertaken at the request of and paid for by other international, national or local organisations; including Rotorua Economic Development. Such travel may be undertaken at the discretion of the elected representative.

8.3 MAYORAL AND ELECTED REPRESENTATIVES INTERNATIONAL TRAVEL POLICY

Policy Purpose:

To guide decision making in relation to international travel undertaken by the Mayor and/or councillors as elected representatives of the Rotorua District, that is not covered by 23.1 Sister City Relationship Policy.

Policy:

There are occasions when the Mayor and/or elected representatives may be invited or required to attend international events overseas as representatives of Rotorua at the cost of the ratepayer.

Proposed travel needs to be supported by a business case that outlines the benefits of the travel against the following criterion:

- The travel/activity must support council's vision, business objectives and aspirations for the future as encapsulated in the Long-term Plan, or
- 2. The travel/activity must support council's current priorities and/or flagship projects.

The business case to be approved by a recommendation from the CEO to council.

Generally travel costs of accompanying persons will not be paid for.

At the conclusion of the travel the elected representative is required to provide a written report to council.

This policy does not include travel by the Mayor and/or elected representatives that has been undertaken at the request of and paid for by other international, national or local organisations; including Rotorua Economic Development. Such travel may be undertaken at the discretion of the elected representative.
