

The "Save Our Iconic Lakeland Queen" society was recently formed. It's purpose is:

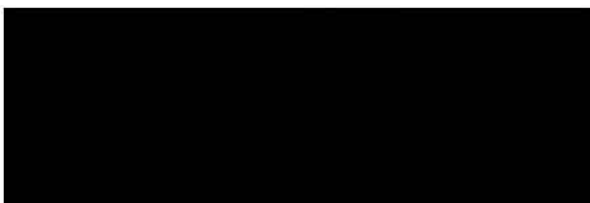
"To assist with the restoration of the iconic Lakeland Queen tourist attraction back to its rightful place, operating on our lake."
