The Chair welcomed Board members, staff and the public.

1 KARAKIA WHAKAPUAKI OPENING KARAKIA

Cr Barker opened the meeting with a Karakia.

2 PROVERB – WHAKATAUKI

Mr Guyton presented the Whakatauki:

He kaha ake te korero a te mahi I nga kupu – actions speak louder than words

3 PUBLIC FORUM

Tina Rose, Mamaku Community Association commented on the following points:

- Acknowledged the work undertaken to date by Rotorua Lakes Council (RFS662566)
- The open drain in Mamaku Street has large hole in it which is a health & safety and environmental risk. A request for service (RFS) has been lodged.

No response has been received.

• A RFS (664130) has been lodged for an update on the earthquake building status of the Mamaku Hall.

No response has been received.

A RFS (RAMM #35-10442) has been lodged to seal/repair a piece of road near the kissing gate,
 Mamaku Street.

No response has been received.

- A RFS has been lodge for a copy/access of the Mamaku Civil Defence Plan.
 - No response has been received.
- The drain opposite the "rail cruising" sight is a "trip" hazard (RAMM #35-16980)
- Ref. email received from Kelly Harland:
 - To consider reducing the speed limit to 50kph into Mamaku Village from South Road & improve signage.
 - The visibility of the "stop" sign onto South Road is poor & needs improving.
 - Multiply families living in Tawhero West have children walking to Mamaku School. There are no footpaths. They are crossing the road at the "stop" sign coming out of South Road where traffic coming into the village is travelling at 100kph. The speed limit needs to be reduced.
- Have asked for feedback from Mamaku School, parents & children around speed limits around the school area.

Mr Thomass commented that there has been a "Rural School Road Safety Review" completed for RLC & Waka Kotahi.

ACTION POINT: Locate the Rural School Road Safety Review & distribute to members. (Rick)

Rachel Mathews expressed concern that review of speed limits had been pushed out to 2024/2027 & the contractors won't drive down Tawhero Street West to collect rubbish & resident have to push their bins over the road for collection.

Chris Paterson provided an update on the Kaharoa communities Emergency Management Plan and commented on the following points:

- The existing Neighbourhood Support Group network provides a comprehensive support service
- There is a community register that lists nurses & engineers etc.
- The local community are aware of where their infrastructure is located e.g. water supply.

ACTION POINT: Discuss Emergency Management Planning: Ben Hollier, Chris Paterson, Tina Rose & Linda Johnstone, Civil Defence & Emergencies Co-ordinator to respond.

Ben asked community members to forward devolved funding ideas to the committee for their consideration e.g. Mamaku Hall improvements

7 NGĀ PŪRONGO Ā-WAHA VERBAL UPDATES

7.1 Mamaku Toilet progress.

Mr Hollier gave a verbal update & commented on the following points:

- A resource consent exemption has been granted.
- A building consent exemption is under action.
- The toilet unit is due to arrive March 2023.
- Installation will take approximately 1 week.

7.2 Devolved Funding – next steps.

Mr Kieck commented on the following points.

- The annual devolved fund of \$125k is still available to allocate.
- The board needs to decide on their funding priorities.
- Possible projects for devolved funding:
 - CCTV camera installations. An individual camera can cost up to \$50k each.
 - School road safety initiatives. The Rural Schools Road Safety Programme prioritised schools that were in most need of road safety improvements.
 - Bus shelters. There is a need for refurbishment however there is no funding available from Waka Kotahi or Ministry of Education. Ngakuru School have requested two bus shelters. Approximate cost is \$15k plus installation.
 - Community halls. There are 9 community halls, 7 are in rural areas. Installing heat pumps is an option for the board. The estimated cost for each unit if between \$5k & \$10k. New kitchen stoves is also an option.

Resolved:

"That the Rotorua Rural Community Board allocate Devolved Funding for Community Hall improvements and Rural School Road Safety improvements."
