Noted the apologies from Cr Bentley for early departure.

5. TEMPORARILY SUSPEND 'STANDING ORDER NO 21.5 – MEMBERS MAY SPEAK ONLY ONCE'

Standing Order No 3.5 provides for a temporary suspension of standing orders as below:-

Any member of a council, committee, subcommittee and subordinate body, and local and community board may move a motion to suspend standing orders at a meeting of which they are a member. Any such motion must also include the reason for the suspension. If seconded, the Chairperson must put the motion without debate and at least 75 per cent of the members present and voting must support the motion for it to be carried. cl. 27(4), Schedule 7, LGA 2002

As per the above provision, it is recommended to suspend 'Standing Order 21.5 - Members may speak only once' to allow members sufficient opportunity to undertake Representation Review deliberations at the Strategy, Policy and Finance Committee Meeting on 16 November 2021.

6. PŪRONGO KAIMAHI STAFF REPORTS

6.1 YOUR CHOICE - 2022 REPRESENTATION REVIEW – DECISION MAKING FOLLOWING CONSULTATION

Resolved:

1. That the report titled "Your Choice - 2022 Representation Review – decision making following consultation" be received.

Moved: Mayor Chadwick Seconded: Cr Macpherson CARRIED

Oonagh Hopkins introduced Mr Lachlan Muldowney, Barrister as the legal advisor. Mrs Hopkins, Mr Rick Dunn and Mr Kihi Tawhai spoke to a presentation titled "Representation Review 2022 - Decision making following consultation" (Attachment 1).

Mayor Chadwick commented that taking into consideration the restrictions in the electoral act to adopt the preferred model (3 seats from Māori ward, 3 seats from the General ward and 4 "At- large" seats), sought clarification from Mr Muldowney regarding the process that council needs to follow to adopt the preferred model.

Mr Muldowney informed the committee that if Council wished to pursue being able to adopt a preferred model as noted above it would have to pursue this through a targeted local bill process presented to parliament

Attendance: Cr Yates joined the meeting at 10.25am.

There was discussion around, a model that is lawful and meets Council's principles needing to be adopted in order to meet legislative timeframes in the Local Electoral Act for Representation Reviews.

A lawful and principled model of 1:1:8 was discussed.

Explanation was provided to give a high level overview summarising the Representation Review process and the points at which all elected members and board members were involved. It was also outlined that following Council's direction the preferred model was tested with the Local Government Commission and legal advice sought on how to achieve a lawful model and meet the Council's principles. The consultation and hearings phase was further clarified in stating the Council does not go back to any submitters when it has moved into the stage of presenting information from the submitters/hearings to the committee/council for decision making.

Attendance: Mr Biasiny-Tule withdrew from the meeting at 10.32am, in protest at the process followed to develop the recommendations within the report.

The meeting adjourned at 10.55am and resumed at 11.10am.

Mayor Chadwick signalled that she would move recommendations 2A, 3 & 4.

Further resolved:

- 2A. That the committee after considering the submissions and requirements of the Local Electoral Act recommends to Council to adopt a final representation model that consists of:
 - 1 Mayor elected at large
 - 1 Māori ward with 1 seat
 - 1 General ward with 1 seat
 - 8 "At large" seats
 - A Rotorua Lakes Community Board
 - A Rural Community Board
- 3. That the committee notes that despite the recommended option, a different model, consisting of 3 Maori ward seats, 3 General ward seats and 4 at large seats is the preferred model for representing the best needs of Rotorua in accordance with the principles of the Local Government Act and the Treaty of Waitangi, but that this model is not enabled under the current legislation.
- 4. That the committee recommends to Council that it instruct the Chief Executive to pursue the necessary statutory reforms, or other means, by which the preferred model can be adopted by Council at the earliest possible time, including if possible, prior to the 2022 election.

Decision making following consultation Strategy, Policy & Finance Committee 16 November 2021



Purpose

Consider the submissions received and make a recommendation to Council on a final representation model for the 2022 and 2025 local elections.



Guiding principles

Keep it simple

Council encourages all eligible persons to have their say on the best people to represent the Rotorua District. The model needs to avoid a level of complexity and confusion that may create barriers to understanding the way voters can vote and could lead to poor voter turnout.

Guiding principles

Total number of councillors

Council agrees that the total number of councillors should:

- Reflect our district's diversity
- Ensure voters can easily engage with councillors
- Balance the workload of councillors
- Bring a range of skills and knowledge to the table
- Represent communities' needs and interests across the district.





Guiding principles

Fair and effective representation (meet requirements of Local Electoral Act)

must provide for 'effective representation of communities of interest' (*ss19T and 19U*) and 'fair representation of electors' (*s19V*). Therefore, there are three key factors for local authorities to carefully consider. They are:

- communities of interest
- · effective representation of communities of interest
- fair representation of electors.

Treaty of Waitangi and Rotorua Township (Fenton) Agreement

Council acknowledges the recognition of the Treaty of Waitangi into the Local Government Act. Section 4 of the LGA 2002 states "In order to recognise and respect the Crown's responsibility to take appropriate account of the principles of the <u>Treaty of Waitangi</u> and to maintain and improve opportunities for Māori to contribute to local government decision-making processes, <u>Parts 2</u> and <u>6</u> provide principles and requirements for local authorities that are intended to facilitate participation by Māori in local authority decision-making processes."



Consultation proposal 31 August 2021

Themes following consultation

Equity/Equality - "everyone being equal" or "everyone should have the same".

<u>Treaty of Waitangi - strongly advised</u> Council to be structured in a manner consistent with the principles of the Treaty of Waitangi.

<u>Co-Governance</u> - arrangements for joint decision-making between iwi and/or other groups, central government, and/or local government.

Inclusion of a Rural Ward - raised the issue of effective representation of the Rural voice at the decision-making table.

Equal Suffrage - Universal Suffrage provides the opportunity to qualifying citizens the right to participate in the voting process (right to vote). Suffrage does not apply to the voting criteria such as how many votes each person has, proportion of votes based on population (Proportional Representation).
