Cr Kumar made comment to the proposed committee and asked if it is possible to elect other members for a more diverse contribution as the proposed members are all of Māori descent.

Point of clarification

Cr Donaldson clarified that 2 of the 3 Council representatives proposed for this committee are not of Māori decent and that Cr Kumar's statement was incorrect.

Ms Rangi clarified that members were selected, as they are existing members of partnership and protocol boards the Council currently operates. They're familiar with partnership agreements that are the subject of the Council committee so its more beneficial to appoint members who are currently involved.

Ms Rangi also noted members to protocol and partnership boards were approved by Council at the beginning of this year.
