

ROTORUA DISTRICT COUNCILTHE ROTORUA DISTRICT COUNCIL DOG CONTROL BYLAW1990, AMENDMENT NO. 1, 1993POWERS AND AUTHORITIESSPECIAL ORDER

That in exercise of the powers and authorities conferred upon it by the Local Government Act 1974, The Dog Control and Hydatids Act 1982, The Health Act 1956, and all other powers and authorities so enabling it, the Rotorua District Council does by Special Order make this Bylaw, and which shall be called the ROTORUA DISTRICT COUNCIL DOG CONTROL BYLAW 1990, AMENDMENT NO 1, 1993.

1. SHORT TITLE

This Bylaw may be cited as "The Rotorua District Council Dog Control Bylaw 1990, Amendment No. 1, 1993".

2. COMMENCEMENT

This Bylaw shall come into force on the 12th day of July 1993.

3. ENACTMENT

This Bylaw shall be read with and amend the Rotorua District Council Dog Control Bylaw 1990 (hereinafter called the Principal Bylaw).

4. REPEALS AND AMENDMENTS

- (a) That "Clause 4 - Interpretation" of the Principal Bylaw be amended by deleting the following words "...Control in relation to any dog means that the owner shall have the power of directing or commanding the dog in unforeseen circumstances whether because the dog is on a lead or otherwise..." and inserting the following words "...Control in any public place means on a leash not greater than two (2) metres in length unless the dog(s) is/are on an area designated by Council as a Dog Exercise Area ..." in substitution thereof.
- (b) That "Clause 5 - Control of Dogs" of the Principal Bylaw be amended by:
- i) At Clause 5(ii)(b) by deleting the following words "... If it is found at large in any public place in contravention of any regulation or bylaw ..." and inserting the following words "... No dog owner or person having the dog in their possession shall cause or permit any dog kept by them to enter or remain in any public place unless the dog is kept under control by the way of a leash not greater than two (2) metres in length held by that person, unless that dog is in an area set aside by the Rotorua District Council and stipulated in the Fourth Schedule to this Bylaw as a designated Dog Exercise Area ..." in substitution thereof;

- ii) That a new clause be inserted to be read as Clause 5(ii)(c) and read as follows "... No dog owner or person having a dog in their possession shall cause or permit any dog owned by them to be in any public place to be at large unless that dog is in an area set aside by the Rotorua District Council for the exercise of dogs as stipulated in the Fourth Schedule to this Bylaw ...".
- (c) That "Clause 9 - Female and Diseased Dogs" of the Principal Bylaw be amended by:
 - i) Deleting the following words "... No dog owner whose dog is infected with any disease including mange or distemper or whose dog is a bitch in season shall take his dog onto any street or public place or allow his dog to go onto and remain there ..." and inserting the following words "... No dog owner or any person with a dog in their possession that is infected with any contagious disease including mange or distemper shall allow that dog in any public place unless that dog is being taken into the care of a veterinary surgeon ..." in substitution thereof to be read as Clause 9(i);
 - ii) That a new clause be inserted to be read as Clause 9(ii) as follows "... No dog owner shall permit any female dog owned by him/her in any public place while that dog is in season ...".
- (d) That "Clause 12 - Limitation of number of dogs on any land or premises" of the Principal Bylaw be amended by:
 - i) At Clause 12(i) deleting the following words "... No dog owner shall keep or allow to be kept more than two (2) dogs for any period exceeding thirty (30) days on any premises within the Urban Zones or the Rural 4 Zone or the Rural 5 Zone of the Rotorua District Scheme unless he has obtained a licence to do so from the Council ..." and inserting the following words "... No owner of any premises or dog owner shall keep or cause to be kept or have in his/her care more than two (2) dogs of a greater age than three months within the Urban Zone or Rural Zones 4 or 5 of the Rotorua District Scheme unless a kennel licence has been obtained from the Council permitting more than two (2) dogs to be kept at those premises..." in substitution thereof.
- (e) That the Second Schedule of the Principal Bylaw be deleted and the Second Schedule to this Bylaw be inserted in substitution thereof, which shall read as follows:

- a) All of Tutanekai Street, Rotorua.
- b) Fenton Street from the Whakaue Street intersection to Victoria Street intersection.
- c) All of Hinemaru Street, Rotorua.
- d) All of Amohia Street, Rotorua
- e) All of Whakaue Street, Rotorua
- f) All of Pukaki Street, Rotorua
- g) All of Arawa Street, Rotorua
- h) Haupapa Street from Ranolf Street to Hinemaru Street, Rotorua.
- i) Pukuatua Street from Ranolf Street to Hinemaru Street, Rotorua
- j) Hinemoa Street from Ranolf Street to Hinemaru Street, Rotorua
- k) Eruera Street from Ranolf Street to Hinemaru Street, Rotorua
- l) Amohau Street from Ranolf Street to Hinemaru Street, Rotorua

The above written streets shall be defined as being inside the Rotorua Central Business District.

- (g) That the following Reserve areas be formally set aside as Dog Exercise Areas where dogs may be exercised off a lead providing they are under constant supervision and control of their owner(s) or the person(s) who at the time the animal(s) is/are being exercised has the dog in his or her possession and that the new schedule be read as the Fourth Schedule and inserted as follows:

Western perimeter Goldie Street/Pukehangi Road

Between Sunset Primary and Intermediate Schools, adjacent to Otomatea Stream

Access off Icarus Place, Pegasus Drive, Castor Place, Helena Place and Orion Street.

9. SIMMONDS CRESCENT RESERVE (NOW TIHI RESERVE)

Access Simmonds Crescent, Day Place, Tihi Road

10. BOYES PARK

Access Carlton, Wylie, Duncan, and Ranolf Streets

11. PERERIKA STREET (TOWN BELT)

Area from St. Michael's Scout Hall to Telecom entrance.

12. MCINTYRE AVENUE

Access McIntyre Avenue and Marguerita Street.

13. LARCY ROAD RESERVE

Access Larcy, and Lynbert Roads
