**MATERIALS**

All memorials to be made of either granite, marble, concrete with plaster, porcelain, ceramic and in some instances bronze. The use of other materials will require Council approval prior to use.

**OFFENSIVE WORDING AND DESIGN**

No individual monument shall cause offence or unfairly overwhelm adjacent areas either by design, wording or other mark.

**MEMORIAL RESTRICTIONS****GENERAL AREA****BASE**

Bases for all memorials shall not stand higher than 150mm above the highest point of the concrete berm.

The depth (front to back) to be no greater than 500mm. Depending on the size of the concrete berm, a minimum space of 100mm is to be maintained both front and back of the base. This means that, for example the concrete berm is 600mm wide then the depth of the base can only measure 400mm.

The width (left to right) of the base is to be no wider than 1000mm, in the case of a double side by side plot 2200mm.

**MEMORIAL**

No erected memorial shall have a completed height higher than 1200mm above the concrete berm. Such memorial shall comply with NZS 4242:1995 Headstones and Cemetery Monuments as a minimum and shall be aesthetically acceptable to the controlling authority (Rotorua District Council). The plans of such memorials shall be submitted to, and approved by, the Rotorua District Council before the erection of any such memorial is permitted.

**CHILDREN'S MEMORIALS**

The following restrictions are only for those areas set aside for children, known as Children's Lawns.

A base no greater than 500mm x 300mm x 100mm thick. A memorial above the base to a height no greater than 500mm. Total height of memorial not to exceed 600mm,

**FLAT LAWN PLAQUES**

Plaques in this area to be no greater than 500mm x 400mm. Plaques are plastered on the concrete berm to a maximum height of 150mm at the back, angling down to 30-60mm at the front. Plastering is to match the existing memorials in the flat lawn area. For memorials within an RSA section these must be purchased through Veterans' Affairs New Zealand contact RSA for details.

**REMOVAL OF UNPERMITTED MEMORIALS**

The Rotorua District Council reserves the right to remove any memorial placed within any of its cemeteries that has not obtained a Memorial Permit. Any such memorial will be held for a period of no less than two months prior to disposal. All such memorials can be collected by the family and or applicant. The Rotorua District Council will allow such memorials to be restored within the cemetery subject to a memorial permit being approved and the payment to the Rotorua District of any costs it incurred due to taking this action.
