

Reflections on another year

I am very proud to be your mayor for another term and look forward to continuing to work with the community to keep our wonderful district moving

Now, as we head into the festive season and our summer holidays, it is a good time to reflect on another year in which Rotorua has continued to thrive.

We have a local economy performing above the national average, unemployment dropping, tourism continuing to boom and retail trade increasing.

We've also had new

businesses establishing here, new buildings going up and redevelopment by existing businesses and it's been great to see that activity.

There's more interest in Rotorua as a place to live and invest, reflected in rising house prices and pressure on our housing stock but we know new residential subdivisions are on the horizon which will ease that pressure.

Meanwhile, our population is growing, passing 70,000 this year and reversing a decade long decline pre-2014, so we are thriving and growing.

Recently we also had the announcement that Rotorua has secured the Crankworx festival for another 10 years, which is unprecedented. It's an event that's really captured the whole community as well as providing a huge economic boost that extends well beyond the week-long event itself.

It's important we keep the momentum going while also dealing with challenges that present themselves – like the unforseen closure of our museum and the need for investment in our roading and other infrastructure.

Council will continue collaborating to deal with these issues.

Since October's election the new council, along with members of the new rural and lakes community boards and Te Tatau o Te Arawa board, have gone through a thorough induction and we're gearing up to start 2017 with renewed energy. Along with Te Tatau representatives, we also now have community board representatives at the committee table and that diversity provides different perspectives which will be extremely valuable in our decision-making.

We will soon be coming out to the community for input into prioritysetting for the next three years to build on progress we've made to-date towards the district's 2030 goals. Part of ensuring the district continues to prosper is making sure we focus on the right things, the things that will help us progress further.

The Rotorua 2030 aspirations still apply but we need to be more specific in terms of how we are going to achieve them. We need to define our district's strengths and future opportunities and then consider how we can maximise those to help us identify where our focus needs to be.

Elected members have started this process and we're calling this The Rotorua Way. What we've done to-date will provide the basis for discussion with the wider community. We want to know what you think, we want your ideas and input, to ensure we're on the right track.

The Rotorua Way won't replace Rotorua 2030 but will provide focus across the next three years and I look forward to discussions with you about this.

Something the election has reinforced is how important it is that our community is engaged and residents feel they can have an impact on the things that affect their lives. We'll continue to engage with the community through the work of our portfolios but will also be looking at new ways to engage to try and reach a broader range of people.

Easter Sunday shop trading policy open for submissions

Rotorua residents are encouraged to have their say about an Easter Sunday Shop Trading Policy for the district.

Submissions open on Monday, 19 December, and close on 27 January 2017. Submissions will be heard in February before a final recommendation goes to council. It is proposed the final decision be made in time for retailers to implement the new policy by Easter Sunday 2017.

Earlier this year, the Government amended the Shop Trading Hours Act 1990 (Act) to allow territorial authorities to have a policy to permit shops to open on Easter Sundays. The changes do not apply to other holiday dates such as Easter Friday, for which current trading restrictions will remain.

Currently most shops in Rotorua cannot open on Easter Sunday, with the exception of dairies, service stations, takeaway outlets, restaurants and cafes, garden centres and duty free stores. Although some tourist areas have had exemptions to open on Easter Sundays in the past, Rotorua did not.

The direction for the draft policy has been informed by the previous position taken by Rotorua Lakes Council to lobby for change to Easter Trading laws, a position supported by a 2014 Colmar Brunton survey which saw 79% support for allowing Easter Sunday trading.

Councils have the option of not adopting a policy, in which case shops must remain closed on Easter Sunday as they have until now, or adopting a policy allowing businesses to open, either in a defined area or across a district.

The proposed policy for Rotorua is to allow shops in the whole of the district to be open on Easter Sunday.


Council markets
