Culture, heritage and tourism: protection of Rotorua's heritage



Indicator 3.2 Protected iwi heritage, archaeological and heritage sites, and NZHPT authorities

STEADY

Purpose of indicator

Rotorua's heritage is a unique and finite resource. Heritage gives a place character and history. Monitoring the retention of heritage sites and structures gives an indication of the recognition and protection that is placed on heritage so that they are retained for future generations.

Current information and trend

Maori heritage is a major component of the heritage and history of Rotorua and is reflected in the number of heritage features and archaeological sites protected by the district plan (Table 3.1). A number of more recent heritage sites and features reflecting the development of Rotorua and Ngongotaha townships, are also recognised by the district plan.

The structure that was lost in the past five years was Pukeroa Cottage. Its removal was due to it losing its structural integrity. A similar building of the same era still remains near the site where the demolished building stood. Retaining heritage buildings and structures in Rotorua is a challenge because of the corrosive properties of sulphur gas.

Table 3.2 shows the type of historic site where authorities were granted. Table 3.3 shows the types and numbers of authorities. Only 12 authorities were granted between 2001-2007. Most of these were for logging operations.
