Message from the Mayor

This document takes us to a new level of information since the previous baseline reporting of the 2002 State of the Environment Report. Importantly, it meets the Rotorua District Council's obligations as set out in the Resource Management Act.

In New Zealand we are fortunate to live in an environment that rates highly against those of most other countries in the world. In Rotorua in particular, we enjoy an environment that is the envy of many other towns and cities around the globe.

When international visitors come to Rotorua they bring with them an expectation that they will experience the clean, green environment that is reflected in New Zealand's international image. The Rotorua Lakes Strategy Group is an innovative partnership between Rotorua District Council, Environment Bay of Plenty and Te Arawa Lakes Trust. Together we are addressing the issue of lakes water quality, and progress has already been made in preparing and implementing specific action plans for a number of our lakes.

Emerging environmental issues that are increasingly requiring more of our attention are climate change and air quality. These issues both need local action to complement national and international endeavors.

This State of the Environment Report is a particularly important publication. It will be of interest to our council, other organisations, agencies and individuals as we all share a vision of a safe, healthy, attractive and sustainable environment for the Rotorua district.
